Rosyth Community Projects Limited is a registered charity based in Rosyth, known locally as EATS Rosyth. We operate a Community Hub in Rosyth, as well as a Community Garden and Centenary Orchard. We provide opportunities in Rosyth for growing, cooking and sharing food. We seek to increase the sense of community in the town through volunteering, education, and community-led activity. We are committed to enabling a diverse range of local residents, volunteers and visitors to participate in our resources to learn, share and enjoy with the aim of bringing about personal growth and a greener community.

# **Main Purpose of Post**

Our Greenspace Coordinator will work together with the Greenspace Development Manager to run programming in our greenspaces, as well as facilitate the maintenance and care of the garden and orchard. This will include the running of existing groups/classes/activities, running community events, running targeted and casual volunteering sessions, and working alongside our regular volunteers to maintain and grow food within our Greenspaces. The successful candidate will have a strong working knowledge of vegetable gardening (including growing in greenhouses and polytunnels across all seasons), and have a confident working knowledge of the care and maintenance of fruit trees and various fruiting bushes and vines. They will be confident working closely with volunteers, and have a passion for bringing out the best in each of them. They will be confident when leading large and small groups in both educational and social activities. They will work sensitively with a diverse range of service users.

They will work closely with the Hub team to develop a food-growing plan for the new Community Cafe. They will work closely with the Greenspace Development Manager to help develop a 3-year Masterplan for the greenspaces.

Our Greenspace Coordinator will work closely with the people of Rosyth, with a strong focus on involving the community in every step of the gardening process.

- Work with our Greenspace Development Manager to deliver activities that engage the community of Rosyth with positive opportunities to learn, understand and take action
- Deliver a wide programme of events, courses, classes and activities in the Greenspaces
- Be a welcoming and approachable face of EATS Rosyth in all interaction with the public
- Engage and work with our community in a way that empowers local people to take ownership of their learning
- Attend local events and groups to promote the work of the project and programmes of activities
- Assist with the recruitment, coordinating, support and supervision of our volunteers
- Ensure all relevant health and safety standards are met in relation to your personal safety, the

safety of volunteers, visiting school or community groups and member of the public using the greenspaces

- Be responsible for the proper use, maintenance and safe storage of all plant, machinery, tools and equipment
- Engage with other local community growing groups
- Adhere to EATS Rosyth's policies and procedures
